Board member Cindy Lee resigned from the board prior to today's meeting.

The PRNC quorum is six. With only five members present, the Board could not take action or any of the agenda items. All 9 of the 11 Board Seats were filled either by appointment or election. Also in attendance were approximately 80 stakeholders and guests.

With only five board members in attendance, the PRNC Board was unable to establish a quorum and therefore could not conduct any business. However, the floor was opened for government representatives to provide their updates and for the public to provide general comments on items that are not on the agenda.

4. Agenda Item 6. Presentation and Discussion of PRCS 7th Grade Leadership Program - Azita Amighi, PRCS

Ms. Amighi who is a math teacher attended tonight's meeting to speak about the 7<sup>th</sup> Grade Leadership Program at PRCS, who then then proceeded to read the school's vision statement and that it offers many programs to its students.

5. Agenda Item 7. Presentations from Government Representatives TBD

Dusty Russell, for Senator Fran Pavley's office wanted to give the PRNC a brief legislative report. Mr. Russell reported on the well inspections and stated that at this time 70 wells are non-operational and that



113 wells have been tested phase 1 out of 114 wells. So far only 17 wells have passed all testing and that So. Cal Gas Company has one year to decide to close the facility or continue with the testing. All of this information is available to the public at the Division of Oil, Gas & Geothermal Resources website at http://www.conservation.ca.gov/dog. Mr. Russell also invited everyone to attend a Gas Storage Regulation Hearing on Thursday, August 11, 2016 from 1:00 p.m. – 5:00 p.m. at the Woodland Hills Hilton.

SB887 Natural gas storage wells - is in the Assembly Appropriations Committee and that this is the final step in getting it passed. This Friday, August 12, 2016 is the last day for any bill to make it out of the Appropriations Committee.

Grace Lee from Assembly Member Scott Wilk's office stated that both AB1903 and AB1904 had passed through the Senate and are now in a suspense file and that their office is optimistic about both bills coming out of committee.

AB2820 having to do with price gouging in states of emergency is currently on the Senate floor and is eligible to be taken up at any time.

Nicole Vartanian, field representative for Congressman Steve Knight's office stated that on June 22, 2016 the Natural Gas Leak Prevention Act was enacted.

Ms. Vartainian stated that on June 20, 2016 the Military Academy had a sendoff for its graduates. The service academy is currently accepting nominations for upcoming Fall 2017 semester. On Saturday, September 17, 2016 from 10:00 a.m. – 12:00 p.m. at College of the Canyon there would be staff available to those interested in attending where they will be given information about the application process and requirements.

Mr. Colin Crews, CD12 Field Deputy for Councilman Englander says that they recently had Nation Night Out at Northridge Park and that they had a good turnout. Mr. Crews said that there will be an upcoming President's Meeting to which Mr. Najm has already RSVP'd to. There will also be a Conversation with Councils sometime in October but the exact date is yet to be determined. There will also be a "drive-in" movie night at Shadow Ranch in West Hills but a date has not yet been set.
